Every business subscriber receives two dialup accounts with it's own electronic mail (e-mail) on the WCNet system. Each account has its own "address." E-mail sent to one account will not be seen by the other.

The first of the accounts (Primary Business dialup account) is in the name of the business and would probably be used for general mail to the business. The second (Secondary Business dialup account) is in the name of a principal or agent of the business, such as the owner or customer service manager, for mail specifically directed to him or her. A business may add additional dialup accounts for the same price as a regular subscriber account (\$95). A business may also add additional e-mail only accounts (\$12).

Wood County Internet Council Subscription Agreement

Subscription agreement of the Wood County Internet Council, hereinafter referred to as "WCNet."

I agree to abide by all policies and follow all procedures of the WCNet. If I violate any policy, I understand that I am subject to possible account revocation at the discretion of the WCNet Board of Trustees.

I agree to release the Wood County Internet Council, its agents, and any institutions with which they are affiliated from any and all claims of any nature arising from my use or inability to use or access the facilities of the Wood County Internet Council or any facility to which it is connected.

I agree that WCNet will not be liable for any indirect, special incidental, exemplary, consequential, or other money damages, including but not limited to lost profits or damages for loss of data or information, delay, nondelivery or misdelivery or service interruption of any kind, however caused, arising out of or in connection with the use or provision of the connection to the Internet, whether based on contract, tort, or any other legal theory, and whether or not WCNet has been made aware of the possibility of those damages.

I agree that if legal action is ever taken against WCNet, the Ohio courts and/or the Federal Circuit Court of the United States of America of which Ohio is a member will have exclusive jurisdiction over any legal actions. I will not use WCNet facilities to commit or encourage illegal activities of any sort.

I agree to assume all risk as to the use of the WCNet's services.

Subscription fees may be refunded up to 30 days after account activation.

Each subscriber will have an account on the system. I understand that this account is for my exclusive use.

I am responsible for usage related to my account and am expected to take responsible actions to keep my password confidential. If I believe my password has been acquired by someone else, I will make WCNet aware of this via the quickest means possible (electronic mail or telephone) so a new password can be assigned or the account temporarily closed for my protection as well as WCNet's.

I agree to check my WCNet EMAIL on a regular basis in recognition of the fact that important communications from WCNet regarding my account are generally sent via this email.

In the case of "Non-Profit" accounts, it is agreed that the organization will prominently display a WCNet poster in prominent public areas of their facilities.

I understand that if I wish to promote commercial activities or publish commercial information that I must purchase a business account. As with information posted by all WCNet subscribers, advertising by business subscribers must comply with the other policies and standards of WCNet.

I agree to lawfully use the facilities of WCNet, especially in the areas of copyrights, trademarks, servicemarks and trade secrets.

I agree to act responsibly and respect fellow subscribers as well as members of the global Internet community. I understand that information found on the WCNet computer system and the larger Internet may present points of view contrary to my own. The posting of inflammatory or harassing messages or content which others find offensive may hinder the mission of WCNet, Inc. and interfere with other subscribers' use and enjoyment of the WCNet computer system. Abuse of subscriber privileges could lead to removal of my account.

I understand that the WCNet Board of Trustees neither approves nor disapproves of content, topics, subject matter, or points-of-view of individuals or groups using the WCNet computer system.

I will comply with Internet etiquette regarding email including properly identifying the originator of any message.

I will not attempt to impersonate another subscriber.

I will refrain from the use of email for any purpose that is not consistent with the policies of WCNet and/or the Internet.

I certify that I am at least 18 years of age or that I have written permission from my parent(s) and/or guardian(s) before an account will be issued to me for utilization of any WCNet system facilities.

These rules are subject to change at any time without notice. An updated rule list will be available for reference on the main system. I will keep up to date with all notices.
